Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2025 of **Hirwaun & Penderyn Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis of Qualification

Accounting Statement

I am unable to conclude whether or not the Accounting Statement properly presents the Council's receipts and payments and financial position:

- The Council has not provided a full and quantified explanation of variances between the current and prior years' accounts. Therefore I am unable to conclude whether or not the Accounting Statement is a full record of the Council's receipts and payments.

Annual Governance Statement

In my opinion, the Annual Governance Statement is not consistent with the Council's internal controls and governance arrangements for the year:

- Assertion 4 - The Accounts and Audit (Wales) Regulations 2014 required the RFO and Council to approve the accounts by 30 June each year or publish a notice to explain why the accounts were not approved. The Council did not approve the accounts by 30 June and did not publish the required notice.
- Assertion 8 - In our 23/24 audit report we recommended that the Council complies with the Local Government Finance Act 1992. This Act requires the Council to set its precept as its calculated budget requirement. This means that the precept should be stated as a gross sum of money to be received by the Council. The Council's minutes record that the Council determined that its precept by reference to the previous year and the amount of the precept to be

raised is not stated. In their minutes, the Council have again expressed their current year precept as a percentage increase over their prior year precept.

Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council.

Developing a Vision for the Community

I draw attention to the negative response to assertion 1 in the Annual Governance Statement. In exercising its statutory functions, the Council will benefit from having a clear vision for its community that has been developed in partnership / consultation with all sections of the community. Developing this vision will help inform Council plans, budgets and activities to ensure the Council best works with and in the interests of the community.

Further information is provided in the Finance and Governance Toolkit for Community and Town Councils.

Capital projects

The Council did not provide any information in relation to capital projects.


We recommend that the Council reviews the annual audit notice to ensure that all required information is provided on a timely basis.

Notice of Elector's Rights

The dates noted on the Council's notice of elector's rights were inconsistent with each other.

We recommend that the Council reviews their procedures for publishing documents and implements a second stage review prior to publication.

There are no further matters I wish to draw to the Council's attention.
