Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2024 of **Hirwaun & Penderyn Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Unqualified

On the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council:

Assets

Between 2021-22 and n2023-24, the Council purchased a number of benches. However, these have not been included on the schedule of insured assets.

We recommend that the Council reviews its asset register and insurance schedule to ensure insurance cover is provided for all relevant assets.

Precept

The Council must determine its precept in lien with the requirements of the Local Government Finance Act 1992. The precept must equal the Council's calculated budget requirement for the year.

The Council decision to set its precept was flawed in that it determined to increase the precept by 11% compared to the previous year. The Council should determine an actual value of the precept rather than a change from another undisclosed amount.
